On parade day, one representative from each entry must be present to check in, receive entry number and line up information at 5:00pm in Weatherford Hall at the First United Methodist Church .

## Rules, Regulations and Procedures

1. The entry form and liability release form must be received by the Chamber of Commerce office no later than December 4th at 4:00 pm to participate.
2. We ask each entry to represent the theme. This is open to your interpretation.
3. Children ages 12 and under may not walk outside an entry, they must be in a automobile or float unless they are part of a walking unit.
4. There will be NO early exits from parade route. No one will be allowed to get on or off an entry after the parade has stepped off.
5. Demonstrations or performances that stop or delay the parade while in route will not be accepted.
6. **Absolutely no throwing items (ex. candy) from entry to spectators. Failure to comply with this rule will prohibit your future participation in this event.**
7. Entry numbers must be displayed on the **right front** of your entry. Failure to attach the entry number or if entry number cannot clearly be seen by the judges, your entry will not be judged. Please remember to go slowly for judges and spectators to inspect your entry.
8. Santa has already agreed to be a part of this event and will ride at the end of the parade. **DO NOT** include a Santa as part of your entry.

## Parade Route

The parade will step off from the First Baptist Church and First United Methodist Church parking lots on Thomasville, take a left on Broadway Street, take a left on Bettis Street, take a left on Everett Street, take a right on Marr Street, parade will end at the City tennis courts. Please pick up all participants at this location.
